VILLAGE BOARD MEETINGS: Milltown Village Board meetings are held on the second Monday of each month at the Village Hall, 89 Main Street West. Meetings start at 6:30 p.m., unless posted otherwise. Meeting notices are posted at the Village Hall, Library and the Post Office.

ELECTIONS: All elections are held at the Milltown Public Library, located at 61 Main St W. Polls are open 7:00 a.m. until 8:00 p.m. Stop in at the Village Office for voter registration.

BUILDING PERMITS: Permits are required for all work to be done on existing buildings and all new construction. The Application to begin construction is available at the Village Office. Fees are \$100.00 for a new commercial building; \$50.00 for a new residential building (unless there is water/sewer hookup required); and \$25.00 for all other permits. In most cases, before construction can begin, inspection/approval **must** be granted by our Certified Building Inspector, Ben Campbell, who can be contacted at 715-556-3136. Mr. Campbell charges his own fee for inspector services. After his inspection/approval of the building permit application, the actual building permit is issued by the Village Office.

GARBAGE: Garbage is collected on Wednesday (unless Wednesday is Christmas Day, then collection will be the following day, Thursday). Garbage must be put out curbside by 7:30 a.m. Garbage cans are required to be removed from the curbside collection point within 24 hours of pick up. Rates: 35 gal = \$45.00; 60 gal = \$45.00; 90 gal = \$52.50 (per quarter).

RECYCLING: Drop boxes will be available at the Milltown Village Shop located at 201 Industrial Ave. Recycling will be the third weekend of every month.

WATER / SEWER: Water meters are read quarterly. Included on the water/sewer statement is a quarterly charge for refuse, and fire protection. Bills will go out by January 20th, April 20th, July 20th and October 20th. Water/sewer bills may be paid at the Milltown Village Office during business hours or use our drop box after hours.

REAL ESTATE TAXES: The first half or full payments of real estate taxes are due by January 31st, and are to be paid at the Village Office or mailed to **Village of Milltown, PO Box 485, Milltown, WI 54858**. Make checks payable to Village of Milltown. **Please include a self-addressed stamped envelope for a receipt.** The second half is due July 31st and **must** be paid at the County Treasurer's office in Balsam Lake, or mailed to **Polk County Treasurer, 100 Polk County Plaza, Suite 150, Balsam Lake, WI 54810**. The Milltown Clerk's office **will not** accept the second half of property tax payments.

DOG LICENSES: Dog licenses are available at the Village Office. A Certificate of Rabies Vaccination by a licensed veterinarian is needed to obtain a license. A dog license **will not be issued without proof of rabies vaccination**. License Fee: Neutered or Spayed - \$3.00 each; all others - \$8.00 each. If you are sending payment via the mail or putting it in our drop box, **please include a self-addressed stamped envelope for the dog tag to be returned to you.**
