Meeting Minutes

• **6:00 p.m. VILLAGE BOARD MEETING**

CALL MEETING TO ORDER: Meeting was called to order by Village President, Larry Kuske.

ROLL CALL: Present: Joe Castellano, Jeff Erickson, Les Sloper, Aaron Zbleski and Larry Kuske. Absent: Mitchell Galle, and Henry Studtmann Also Present: Kevin Oium and Brandon Sather from Cedar Corporation; Boyd Heilig, Mike Nutter, and Lyndsey Heilig

APPROVAL OF AGENDA FOR MARCH 30, 2026, SPECIAL VILLAGE BOARD MEETING: A unanimous Castellano/Zbleski motion approved the agenda for tonight's meeting as prepared and presented.

APPROVAL OF AGENDA FOR JANUARY 12, 2026, VILLAGE BOARD MEETING: A unanimous Studtmann/Galle motion approved the agenda for tonight's meeting as prepared and presented.

COMMENTS/SUGGESTIONS FROM PRE-REGISTERED CITIZENS: Steve Quist, 520 Milltown Avenue, was in attendance in regards to concerns of fuel tank storage at neighboring property, 507 Milltown Avenue; and concerns regarding shed in front yard at 615 Milltown Avenue.

CEDAR CORPORATION:

Project Bid Award – Dave Cecil Builders. Nine bids were received with one late bid excluded. Dave Cecil Builders (Birchwood, WI) was the lowest responsible bidder at \$2,493,964, which is under the project budget of \$2,554,000. A unanimous Zbleski/Sloper motion approved awarding the contract to Dave Cecil Builders.

Third-Party Special Inspections. The Board reviewed new state requirements mandating third-party inspections for soils, concrete, masonry, and precast. Estimated cost is approximately \$20,360 and will be administered separately from the contractor. A unanimous Castellano/Erickson motion approved awarding CVT- Chippewa Valley Testing, Inc. for Testing and Inspections for the Community Center Site.

PUBLIC WORKS REPORT:

- a. **Sweeper Options.** The Board discussed renting, contracting, or purchasing a street sweeper. [MacQueen Group](#) out of St. Paul, MN was contacted by Mike Nutter on what they had available for street sweepers. Mike will gather pricing, and the board will evaluate financing and cost-sharing options with the Village of Centuria.

OLD BUSINESS:

- a. 113 Main Street West, Milltown, WI- Discussion of unregistered vehicle behind building (Chief Thayer gave a 5-day notice to the owner of the vehicle to prove that it is registered). And it has been brought to the attention that there is a possibility of someone staying at this address.

ADJOURN: A unanimous Erickson/Sloper motion made to adjourn.
